NEW Guidance on Re-Opening Northern, Remote, Isolated Indigenous Communities

ISC has released a final version of their guidance document on re-opening Indigenous communities in northern and remote settings. Please find it attached to this update.

RECAP Alberta Fund to help Indigenous community-owned businesses

As of Monday (June 29), community-owned businesses can apply to the Aboriginal Business Investment fund (ABIF) for initiatives that "demonstrate social and economic benefits for their communities." Alberta is providing up to \$500,000 in investments through this call for proposals. Click here for more information.

Communities must own and control 51 per cent or more of the proposed business or joint venture to be eligible. Eligible projects must demonstrate how they will increase:

- employment opportunities for Indigenous people
- local revenue streams for Indigenous communities
- the economies of Indigenous communities

CALL & MEETING SUMMARIES

July 7 | AFN Chiefs Committee on Health

The Chiefs Committee on Health (CCoH) met today to receive their regular update from FNIHB and, at the request of Regional Chief Poitras, received a presentation from Health Canada about drug shortages. Please find attached the meeting materials. **Key highlights:**

- Updates were provided from the AFN COVID-19 task force working groups as they continue to developing a discussion paper:
 - The pandemic plan working group is working on language about food security, and is focusing on developing guidelines that will have longevity beyond COVID-19.
 - The reopening working group is reflecting on lessons learned to develop guidance on re-opening for FNs.

- The data group is working with FNIGC to make the case for a national health First Nations data strategy. There's a commitment from Canada to present the data views of the task force at a Federal-Provincial-Territorial government table.
- At the recommendation of RC Poitras, Health Canada gave a presentation on drug shortages during the pandemic.
- Health Canada now requires the pharmaceutical industry to report drug shortages.
 These can be viewed publicly on drugshortagescanada.ca
- Health Canada, together with the Province of Alberta, launched a Multi Stakeholder Steering Committee on Drug Shortages (MSSC) made up of government, industry and health care representatives, to work towards a more rigorous and coordinated approach to drug shortages.
- Actions taken during COVID-19:
 - Health Canada has been proactively securing a domestic drug supply through engagement with industry and provincial territorial governments.
 - The Minister of Health signed an Interim Order on March 30 th to help prevent and alleviate shortages of drugs, medical devices, and foods for a special dietary purpose resulting directly or indirectly from the COVID 19 pandemic
 - This order facilitated importation of drugs not approved for use in Canada but that meet comparable manufacturing standards while labelled for other countries (e.g. UK, US English only labelling)
- Canada is now developing an allocation framework to determine how drugs that are in high-demand can be best distributed based on needs. Canada is also exploring creating a national stockpile of drugs.
- Officials were pressed on having more direct communications with First Nations on drug shortages, not just through ISC or provinces and territories, especially as they work on these new policy measures.
- In spite of an increase in COVID-19 cases on-reserve, First Nations continue to have an infection rate four times lower than Canadians, a fatality rate three times lower than Canadians, and a higher recovery rate than Canadians.
- The epidemiological data for First Nations shows that the 20-39 age group is contracting COVID-19 at a higher rate than Canadians. This may explain why the recovery and fatality outcomes are better for First Nations.

RECAP July 2 | Health Co-Management Committee Meeting

Regional Chief Poitras was scheduled to provide an update on the National and Regional actions of AFN during this meeting, unfortunately, prior to the allocated time on the agenda, quorum was lost as there were conflicting commitments - The update has been rescheduled to next Friday. **Below are some other highlights from the meeting:**

 Updates were provided by FNIHB Dr. Wong and Dr. Adam which mirrored the ISC National update with Alberta chiefs last week. For Alberta Dr. Yacoub and Dr. Sarin provided an update:

- Of note was the information about the recent surge of cases in NZ and Calgary Zone, which was attributed to: Increased asymptomatic and symptomatic testing as requested by communities; mass social gatherings in community; and non-essential travel to another community.
- It was stressed that it is important to continue to physically distance and follow other public health measures.
- Also stressed was the importance for the elderly and those with pre-existing or chronic conditions to take additional precautions with their health such as getting the flu vaccine in the fall, and cutting back on smoking.
- Dr. Hinshaw reiterated that Alberta Health Services is available to provide guidance on ceremony. They also had a conversation with public health physicians from Manitoba.
 - Of note: Manitoba has no cases on reserve. They have developed a guidance document on ceremonial practices and COVID protections. They are happy to get copies of this document to chiefs who request it.
- It was further noted that singing will project the virus farther than talking.
- Concern was expressed for elders in long term care facilities. Families are not advised in a timely manner of serious health crisis for elders. In on example an elder was not treated or sent to hospital until the family intervened. AHS is going to look into the two facilities that were mentioned during the call

Canada's COVID-19 Update - July 3rd

The Prime Minister did not provide a COVID-19 briefing today (July 7) as he continues with his virtual cabinet retreat. Speaking from the road on July 3, he highlighted several measures his government introduced to help people during the pandemic. Dr. Tham then provided a brief update. **Key highlights:**

- There have been 104,772 cases including 8,642 deaths. 65% of people have now recovered. Labs nationwide have tested 2.8+ million people for COVID-19. An average of 37,000 people are tested daily, with 1% returning positive.
- Prime Minister trudeau highlighted investments and measures like the \$100 M in funding for Canada's food banks, infrastructure investments in BC, the Canada Emergency Wage Subsidy, which has helped retain 2.8 million employees across the country,
- **Tomorrow**, finance minister Bill Morneau will release Canada's economic and financial snapshot. This will give Canadians a picture of where the economy is right now, how our

response compares to that of other countries, and what we can expect in the months to come.

- Dr. Tham recommends people avoid "the 3 Cs":
 - Close spaces with poor ventilation
 - Crowded places with larger numbers of people gathered
 - Close contacts where you can't practice physical distancing

RECAP Alberta's COVID-19 Update

<u>Chief Medical Officer Update - June 30th</u> Chief Medical Officer Update - July 2nd

Dr.Hinshaw will not be providing any updates on COVID-19 next week (*July 6-10*). Statistics will continue to be available online through Alberta.ca, and should there be any changes that affect public health, the Deputy Chief Medical Officer will step in to inform the public.

- There are now 7,500+ recoveries from COVID-19. On June 30th, the province identified 30 new cases, and yesterday, 64 new cases. There are currently 44 individuals in hospital, with 8 of these in the ICU. 1 additional individual has passed away due to COVID-19.
- Dr.Hinshaw reassured Albertans that should Edmonton be chosen as an NHL Hub city that safety will remain the Provinces' number 1 priority. Health officials will work with partners on guidance to protect the public and those involved in the tournament while assuring public testing will not be impacted.
- **Effective June 30th** Outdoor gathering limits have been expanded to up to 200 people, allowing for audience events like fireworks, festivals, rodeos, sporting events and other outdoor performances.
 - All public health measures are still in effect (2m distancing, mask recommendations, frequent hand washing etc.)

RECAP Premier Kenney Announces Alberta's Economic Recovery Plan

News Release: Alberta's Recovery Plan

Premier's Press Conference

Premier Kenney and Finance Minister Toews announced Alberta's economic recovery plan. **Key highlights:**

- The government will make a \$10 billion investment into infrastructure projects. It estimates this will create 50,000 jobs in Alberta.
 - A total of \$612 million will be invested in large-scale infrastructure projects this summer, which will include the twinning of highways, projects that support growth in the agricultural sector, gas line extensions for northern residents, treatment facilities for Albertans recovering from addictions, and other important projects.
- On July 1, the corporate income tax rate will drop to 8%.
- An Innovation Employment Grant is being created for smaller companies and to encourage investment in technology. According to the government, the grant will provide

- a refundable tax credit to companies that invest in research and development, so they have more money to create jobs.
- Alberta will also reduce its immigration admissions under the nominee program by at least one-third of its annual targets. It will also ask Canada to remove most occupational categories under the Temporary Foreign Worker Program for Alberta.
- Alberta will create a Cultural Event Relaunch Program.
- Alberta has found up to \$500 million in further funding for municipalities. They expect this to be matched by Ottawa.
- The province is establishing the Invest Alberta Corporation -- a new investment agency to help restore economic growth, create jobs, and diversify our economy.
