New Measures

- The province is now allowing **outdoor** gatherings of 50 or more, provided that 2 m physical distancing can be followed, and people are not sharing food or drinks.
 - Indoor gatherings are still limited to no more than 15 people.
- A fire ban continues to be in place for provincial parks and protected areas and on public land. Alberta says this will allow emergency resources to remain focused on COVID-19, not putting out human-caused wildfires and supporting community evacuations.
- Provincial campgrounds remain closed, but day use in provincial parks is permitted. Alberta will reopen campgrounds with limited capacity on June 1.
- Some national parks will also be reopening June 1, with physical distancing measures in effect. with Provincial parks which are also opening on this date.

First Nation-specific Updates

 Minister Miller confirmed Canada will not ban Sundances or other spiritual ceremonies during the pandemic. (Details can be found in the "National and Regional Updates" section of the bulletin).

- *Updated* Canada Emergency Student Benefit applications will open <u>Today</u>.
 Students who have not filed taxes will have to contact CRA to register their Social Insurance Number.

National and Regional Updates

- Alberta is asking businesses to post a short survey about the steps they are taking to
 reduce risk of exposure to the coronavirus within 14 days of reopening. This is posted
 on the <u>Bizconnect website</u> that the province launched on Monday to help businesses
 learn about the public health measures they need to have in place before reopening.
- Seniors will receive a one-time boost to Old Age Security and Guaranteed Income Supplement payments to a maximum of \$500 to deal with the added pressures and costs of COVID-19.
- \$1 billion dollar regional relief and recovery fund announced by the federal government on Wednesday, to flow through the six regional development agencies
- On Tuesday, The Prime Minister announced \$790 million towards vaccinating the world's more vulnerable populations through a partnership with GAVI.
- Prime Minister Trudeau announced cost-sharing agreements with all provinces and territories to top up the wages of essential workers. Final details of these agreements are still being determined.

Canada's COVID-19 Update - May 15

Speaking from outside his home in Ottawa, Prime Minister Trudeau announced funding support for researchers and research institutions and updated the country on measures for financial support the government has undertaken. Following this, Deputy Minister Freeland, Dr.Tam and colleagues provided the daily briefing on COVID-19 statistics and measures. **Key Highlights:**

- There are now 73,829 confirmed cases of COVID-19 in Canada, including 5,499 deaths. 36,528 cases, or 49%, have recovered. On testing, Canada has now tested over 1,232,000 people with about 6% returning positive, testing an average of 27,000 individuals daily.
- \$450 million was announced by Prime Minister Trudeau for universities and affiliated research institutions, providing temporary support on wages.
- The Canada Emergency Wage Subsidy will be extended until the end of August to allow businesses to retain employees and avoid layoffs, re-hiring staff, and expanding if possible. The 30% revenue reduction eligibility criteria will also be evaluated in the coming days.
- Canada Emergency Student Benefit Applications open today, applications can be done through CRA MyAccount or calling CRA.

Additional Information

- The first set of postings for summer jobs for students is up at <u>jobbank.gc.ca</u>, more postings will be up in the coming days for students and recent graduates.
- Recipients of the Child Benefit and GST/HST Credit will not lose their benefits if they fail
 to file taxes until the end of September. The filing deadline for 2019 was previously
 extended until June 1.

Alberta's COVID-19 Update - May 15

In Edmonton, Dr. Deena Hinshaw, Alberta's Chief Medical Officer of Health, provided the daily update from the province on their response to the COVID-19 pandemic. **Key Highlights:**

- There are now 1,073 active cases in the province, with 62 in hospital and 9 in intensive care. 58 new cases have been identified in the past 24 hours.
 - 50 new cases have been identified among asymptomatic people since Monday.
 This week, the province allowed residents in the Calgary zone to get tested for COVID-19 without showing any symptoms.
- The province is now allowing outdoor gatherings of 50 or more, provided that 2 m physical distancing can be followed, and people are not sharing food or drinks.
 - Indoor gatherings are still limited to no more than 15 people.
 - Dr. Hinshaw said if you want to invite people to your backyard you should make sure they can stay 2 metres apart, make hand sanitizer readily available, and If you cannot do this, you shouldn't host a gathering.
- There will no longer be daily or weekend COVID-19 updates from the province. Dr.
 Hinshaw will give her update on Tuesday and Thursday next week, and on Monday,
 Wednesday, and Friday the following week.
- Businesses that are recently reopening will now have 14 days after opening to post a short survey publicly outlining what strategies they have taken to mitigate risk.
 Yesterday, Dr. Hinshaw said businesses would have 7 days after reopening to complete this form. The survey can be found through the bizconnect webpage linked here.
