New Measures

- On Tuesday, December 8, the government of Alberta brought in new health measures
 to be in effect provincewide. The restrictions are to be in place for a minimum of four
 weeks. Full details and link to the press conference just below today's
 highlights.
- *NEW* The province received its first 3,900 doses of Pfizer-BioNTech's COVID-19 vaccine on Dec. 14 and another 25,350 doses are expected at the start of next week.
 - Alberta plans to immunize 29,000 health-care workers by the end of December.

PROVINCEWIDE MANDATORY HEALTH MEASURES

On December 8, 2020 the Government of Alberta introduced the following **additional** restrictions **Province Wide** to be in place for at least 2 more weeks:

Immediate Changes

- No indoor or outdoor social gatherings in any setting
- Close contacts limited to household members only
 - Individuals who live alone will be allowed up to two close contacts for in-person visiting, with those two people remaining the same for the duration of the restriction period
- No festivals, events, parades, concerts, exhibitions, competitions, sports or performances.
- Grades 7-12 at-home learning Nov 30, 2020 to Jan 11, 2021
- ESC-Grade 5 at home learning after break until Jan 11, 2021
- The mandatory indoor public masking requirement has been extended province wide

In effect 12:01 a.m., December 13, 2020

- All places of worship limited to 15 per cent of fire code occupancy for in-person attendance.
- All retail services must reduce customer capacity to 15 per cent of fire code occupancy.
- Mandatory work from home measures will be implemented unless the employer determines that work requires a physical presence for operational effectiveness.
- Closures the following will be closed:
 - Restaurants, Pubs, Bars, Lounges and Cafes closed to in-person
 - Takeout, pickup and delivery services still permitted.
 - Casinos, bingo halls, gaming entertainment centres, racing entertainment centres, horse tracks, raceways, bowling alleys, pool halls, legions and private clubs
 - Recreational facilities fitness centres, recreation centres, pools, spas, gyms, studios, day and overnight camps, indoor rinks and arenas
 - Entertainment business and entities libraries, science centres, interpretive centres, museums, galleries, amusement parks and water parks

CALL & MEETING SUMMARIES

NEW AFN Executive Committee Meeting | December 15, 2020

Following the Virtual AGA, the Executive Committee of AFN met to discuss priority areas, Regional Chief Poitras was in attendance and here are some key highlights from the priority discussion areas:

Chiefs Committee on Education discussions

- The executive moved that the National Chief and AFN Executive Committee support that education funding be based on needs rather than a funding formula.
 - RC Poitras stressed that the Chiefs Committees are recommendatory bodies and do not make decisions on funding allocations.
- National Chief encouraged the executive to lobby the Ministers and Deputy PM Freeland to increase education funding amounts. Advocacy efforts are needed prior to the next

budget in order to have the potential to impact funding amounts.

AFN Chiefs Forum on UN Declaration Bill C-15 Discussion

• National Chief recommended a two-day forum tentatively planned for February 10-11, 2021 on Bill C-15. The motion was unanimously agreed upon.

First Nations Policing and Justice

- A discussion on Justice and Policing was held, and the executive agreed that there are
 regional differences in approaching the issue, and each region has been taking its own
 approach. (e.g. Alberta provincial Government is undertaking a review of the Provincial
 Police Act simultaneously and Regional Chief Poitras has held meetings with both
 Federal and Provincial leaders at the table so First Nations can directly engage on this
 and other processes).
 - It was stressed that the portfolio holders need to be in sync with these regional realities and support was given for a cohesive and cognizant approach.

AGA Recap/Overview - Lessons Learned

- The Executive went over the virtual AGA and discussed some of the limitations and lessons learned for the future. It was conveyed that there was a lot of frustration from not having time to address all Chiefs comments in the virtual space.
 - The Chairs tried to apply rules as they are in the charter as consistently as possible. It was understood that due to the amount of items in the agenda that at times the meeting was running well over 45 past allotted items.
- It was recommended the chairpersons meet and identify the limitations of the virtual AGA and develop a report, with recommendations.
 - The Co-Chairs did note as a preliminary observation the gender disparity that arose and that at times all the speakers to certain issues were men.
 - CEO Janice spoke to next steps, noting that they are recognizing the issues that arose through these follow-up discussions and that a survey will be sent to all participants soon for feedback, and will try to roll-out recommendations in the new year.

Government of Canada COVID Updates

<u>Federal Update on COVID-19 Vaccine Distribution - December 16, 2020</u> Canada to Receive 168,000 Doses of Moderna COVID-19 Vaccine in December

On Parliament Hill, Dr. Howard Njoo, Canada's deputy chief public health officer, conducts a technical briefing concerning Canada's distribution of COVID-19 vaccines. He is joined by Major-General Dany Fortin, the vice-president of logistics and operations at the Public Health Agency of Canada and head of the country's vaccine distribution efforts, Dr. Tom Wong, chief medical officer of public health for Indigenous Services Canada, and Dr. Evan Adams, deputy chief medical officer of public health for Indigenous Services Canada. **Key Highlights:**

- Canadians have started to receive their COVID-19 vaccines. Dr. Njoo stated that he has never seen the global health community come together in this way.
 - Dr. Njoo also stated this was only the beginning of the end, and that we need to keep up our public health measures while vaccinations are underway.
- Provinces are moving to scale up points of use based on their regional immunization strategies. Training to administer the vaccine is also underway.
 - Freezers are being delivered across the country to meet the cold-chain requirements of the vaccines. Provinces and Territories already have ancillary equipment in their possession for the first order of 2021. (syringes, PPE etc.)
- Dr. Evan Adams gave an update on the COVID-19 cases for First Nations across Canada
 - As of December 15 there are 6,390 COVID-19 cases on reserve in Canada with 2,472 of these being active. 50% of all Indigenous communities in Canada have experienced COVID, in particular Alberta, Saskatchewan and Manitoba have been affected. There have been 55 on reserve fatalities.
- The Prime Minister announced that Canada will receive up to 168,000 doses of the Moderna COVID-19 vaccine by the end of December, pending Health Canada's approval of the vaccine.
 - Deliveries could begin within 48 hours of federal regulatory approval.
 - Trudeau also announces that another 200,000 doses of the Pfizer-BioNTech vaccine will be delivered to Canada the week of December 21.
 - This batch is part of the 249,000 doses that Canada will receive by the end of 2020 from its initial shipment of Pfizer's vaccine.

Government of Alberta COVID Updates

Alberta Premier Jason Kenney holds a news conference in Edmonton to provide an update on his government's response to the ongoing COVID-19 pandemic. He is joined by provincial cabinet ministers Tracy Allard (municipal affairs), Kaycee Madu (justice and Alberta's solicitor general), and Rajan Sawhney (community and social services), as well as Dr. Deena Hinshaw, Alberta's chief medical officer of health. **Key Highlights:**

- In the last 24 hours Alberta reported 1,270 new cases of COVID-19 and completed 17,500 tests. Positivity is at 7.3%. There are 749 hospitalized with 139 in the ICU. AHS continues to work to increase capacity and beds available for the ICU. 16 new deaths were also reported in the last 24 hours.
 - In the last 10 months, more Albertans have died from COVID-19 than the last 10 years of influenza combined.
- Addressing Vaccine safety, Dr.Hinshaw stated that it is important to remember that
 Canada has one of the most robust regulatory systems in the world for vaccines and the
 same testing and scrutiny was applied to this as there would be to any new drug. No
 safety concerns have been identified.
 - Effectiveness and Safety needed to be verified before any administration to Canadians, this is part of the reason why no one under 16 may currently receive the vaccine as there has been no trials conducted to this point.
- Alberta's first doses of the Pfizer-BioNTech vaccine were administered to health-care workers in Calgary and Edmonton earlier in the day. Another 25,300 doses are expected within the next week.
 - The first tranche of the Moderna vaccines is expected within a week or so.
- Addressing the measures put in place last week, and continued high rates of transmission, an outreach campaign has begun to 11 neighborhoods between Edmonton and Calgary.
 - Care packages with Masks, Hand Sanitizer and information delivered by community care teams and provided with information on socioeconomic supports that are available to them.
 - As part of this initiative an expansion of isolation support program is being undertaken which will offer 14 days in hotels for people in hard hit communities that cannot effectively isolate. There are 16 hotels ready for them who need them.
 - Additionally, Individuals will be eligible for a temporary emergency payment of \$625 once their mandatory self-isolation at hotels has been completed.
- A public awareness campaign in 10 languages is also being launched so that people have access to information relevant to COVID-19 and vaccination.

NEW Provincial Concerns with UNDRIP Legislation

Two letters were received this week by the AFN National Office. The first is directed to Federal Ministers Lametti and Bennett from the provincial Indigenous ministers of Alberta, Manitoba, New Brunswick, Ontario, Quebec and Saskatchewan; The second is from Alberta Justice Minister Kaycee Madu to Minister Lametti's office. Both of the letters raise concerns about the implementation of the federal UNDRIP legislation, Bill C-15. You can find copies of the letters attached to today's bulletin.
