ALBERTA DECLARES STATE OF EMERGENCY

On November 24, 2020 the Government of Alberta declared a state of emergency in the Province and introduced the following restrictions **Province Wide** to be in place for at least 3 weeks:

- No indoor social gatherings in any setting
- Outdoor gatherings max of 10
- Wedding and funeral services max of 10, no receptions permitted
- No festivals or events
- Grades 7-12 at-home learning Nov 30, 2020 to Jan 11, 2021
- ESC-Grade 5 at home learning after break until Jan 11, 2021
- Working from home should be considered where possible

The following additional restrictions apply to areas of the province under **Enhanced Areas** (color coded purple in the interactive map link above).

- Places of worship at ⅓ normal attendance with mandatory masking
- Restricted access to some businesses starting Nov.27

Lastly, for the Edmonton and Calgary Zones the government has introduced mandatory masks for indoor workplaces. You can find further details including which communities are included in the Calgary and Edmonton zones at alberta.ca/enhanced-public-health-measures.aspx

Updates from Indigenous Services Canada (ISC) AlbertaFunding update

On November 20, Minister of Indigenous Services Canada announced \$52.15 million in additional COVID-19 funding support for Alberta Indigenous communities in response to the alarming rise in COVID-19 cases. This funding supports Nation-driven, on-the-ground pandemic response efforts. This new funding allocation is in addition to recent funding announcements including the October 2020 enhanced COVID-19 Mental Wellness Funding and ICFS Round 2 funding.

CALL & MEETING SUMMARIES

NEW COVID-19 Task Force | December 2, 2020

Two key presentations were made to the AFN COVID-19 Task Force:

- COVID-19 Vaccine Planning (Public Health Agency of Canada)
- First Nations COVID-19 Epidemiological Update (First Nations Inuit Health / Indigenous Services Canada)

COVID-19 Vaccine Roll-Out Planning

The presentation outlined the current efforts regarding COVID-19 vaccine access for Indigenous populations. Recognition of the historical issues was mentioned with a need to earn trust; engage Indigenous people in planning; provide evidence informed choices; adapt based on distinct population needs; and build a sustainable approach to support Indigenous access to immunization services.

Lessons learned from previous pandemics including H1N1 include role clarity and accountability between all levels of government. The needs of urban, remote, and isolated communities are being discussed with respect to challenges faced and as a priority for immunization.

The COVID-19 immunization program is the most complex in Canada as it is occurring during an evolving pandemic. There is an "initial objective to be ready to immunize with a limited vaccine supply by January 2021".

Key objectives of this plan include: Building vaccine confidence; Partnering for Success – Focusing on Indigenous Engagement; Obtaining sufficient vaccine supply for all Canadians; Identifying priority recipients based on expert advice; Advance planning to ensure readiness for equitable vaccine roll-out; and Timely information on vaccine safety, uptake, and effectiveness. ISC and PHAC are to host regional round-tables to provide updates and outline varied steps in the roll-out process. This will require leadership engagement and participation at the

engagement sessions.

Regional Chief Poitras asked specific questions about the efficacy of two vaccines – Pfizer and Moderna, recognizing there are several vaccines currently being developed. General responses were provided about the approval process as they are ongoing.

First Nations COVID-19 Epidemiological Update

Epidemiological information provided by Dr. Evan Adams included key trends:

- Compared to the "first wave" of COVID-19, First Nations communities new and active cases are about 10 and 14 times higher
- The overall death rate in First Nations COVID-19 on-reserve cases is 6.8 per 100,000 populations compared to 32.0 per 100,000 in the general population
- There have been 3,981 cases reported as First Nations on reserve to November 30, 2020
- Since early September, there has been a steady increase in the number of new on-reserve cases reported, mostly in Alberta, Saskatchewan, and Manitoba

Government of Canada COVID Updates

CPAC Video Link: PM Trudeau COVID-19 Update - December 1, 2020

As of 4:30 a.m. ET on Wednesday, Canada's COVID-19 case count stood at 383,468, with 66,369 considered active. Deaths sit at 12,211. Prime Minister Justin Trudeau briefs Canadians on the federal government's response to the ongoing COVID-19 (coronavirus disease) pandemic. **Key Highlights:**

- PM Trudeau sought to reassure that his government will be ready to deploy the vaccine soon after they receive the necessary Health Canada approvals.
 - He said the independent scientists reviewing the clinical trial data submitted by the drugmakers are working hard to ensure the safety of these products.

- The government is preparing to spend up to \$100 billion to kick start the post-pandemic economy as it stares down a record-high deficit projection of more than \$381 billion for this fiscal year.
- A range of new measures were outlined in the fall economic statement tabled by Deputy
 Prime Minister Freeland yesterday including;
 - Boosting the Canada Child Benefit with temporary support up to \$1,200
 - o Elimination of Interest on federal student loans for 1 year.
 - Small Business Salary Subsidy will be strengthened
 - Farmers will see a bolster to supply management.

Government of Alberta COVID Updates

CPAC Video Link: Premier Kenney COVID-19 Update - December 2, 2020

In Edmonton, Alberta Premier Jason Kenney and Dr. Deena Hinsaw, the province's chief medical officer of health, provided an update on the provincial response to the ongoing COVID-19 pandemic. **Key Highlights:**

- There are 17,144 cases of COVID in Alberta. 1,685 new cases for a positivity rate of 9.2%. 904 are hospitalized with 97 in the ICU. 10 more Albertans have passed.
- Kenney spoke to development of COVID-19 vaccines and the distribution availability coming within weeks and preparing for the rollout.
 - Municipal Affairs Deputy Minister Paul Winnick has been appointed the lead of the COVID-19 Vaccine Task Force.
- The Alberta government will not make any mandatory vaccination rules.
 - The Public Health Act rules around mandatory inoculation that have been in place since 1910 will be removed.
- There are 30 vaccine depots located throughout the province. Phase 1 assumes that approximately 435,000 Albertans will receive the vaccination to cover approximately 10% of the population.
 - AHS Phase 1 will focus on the most at risk populations, that is, Residents of long-term care homes, On-reserve First Nations individuals aged over 65, Seniors aged 75 and older, and Healthcare workers to ensure workforce capacity.
 - Phase 2, from April to September next year aims to inoculate approximately 30% of the population.
 - Phase 3, in the fall, is likely when a vaccine will be available to the General Alberta population.

The province has completed its series of four engagements on review of the Provincial Police act and is now accepting written submissions with any perspective or feedback to be provided. The Nation Rebuilding Program or "NRP" is accepting applications from Indigenous Nations and organizations to fund initiatives that will serve to strengthen and express Indigenous Nations' unity and individual national identity. The goal of the NRP is to support nation rebuilding efforts at the nation level. **The deadline for the 2021-22 call for proposals is Monday, December 14, 2020.**
