Updates

First Nations COVID-19 response in Alberta – Highlights

Alberta Health Epidemiology and Surveillance reporting team is tracking all cases of COVID-19 among First Nations individuals in Alberta on and off reserve. As of June 3, 2020, this report showed 170 cases among First Nations people on and off reserve, as compared to 7,091 cases among all Albertans. First Nations in Alberta have a COVID-19 case rate of 0.10% compared to non-First Nations with a case rate of 0.16%. There have also been 11,108 tests performed on First Nations out of the 229,369 people tested in Alberta. First Nations have a testing rate of 7.75%, a higher rate than the rest of the population at 6.03%. The comprehensive response in First Nations helped prevent the first COVID-19 case from arriving on-reserve until April 20, 2020, over six weeks after the first positive case in Alberta. To date, only seven First Nations have reported cases.

CERB and Income Assistance:

As a reminder, the Canada Emergency Response Benefit (CERB) and Income Assistance are separate programs and individuals may not be eligible to receive Income Assistance if they receive CERB. CERB may provide temporary income support to an individual member who has worked in the last 12 months and has stopped working or lost income, in quarantine or sick, taking care of others in quarantine or sick and/or taking care of children or dependents because their care facility is closed due to COVID-19. Individual members receiving federal or provincial benefits such as Income Assistance, Assured Income for the Severely Handicapped or Canada Pension Plan should check with their specific program caseworker to determine what impact receiving CERB may have on their benefits. It's the individual applicant's responsibility to review the CERB eligibility criteria. If an individual has already received CERB and realizes they are not eligible, the funds can be sent back in order to continue to be eligible for income assistance benefits. Question of the Day

Q: What further financial relief is available to the seniors in our communities?

A: The Prime Minister has announced that seniors eligible for the Old Age Security (OAS) pension and the Guaranteed Income Supplement (GIS) will receive their special one-time, tax-free payment during the week of July 6. Through this measure and others, the government is providing nearly \$900 more for single seniors and more than \$1,500 for senior couples, on top of their existing benefits, to help with extra costs during the pandemic. Seniors eligible for the OAS pension will receive a payment of \$300, and those also eligible for the GIS will receive an additional \$200, for a total of \$500.
