New Measures

- Dr. Hinshaw recommends all Alberta teachers and school staff to get tested before September. She says children should be tested only if they have symptoms or preexisting conditions similar to COVID-19.
- Some pharmacies in Alberta are offering asymptomatic COVID-19 testing. Click here for the list of participating pharmacies.
- Dr. Hinshaw recommends storing clean reusable masks in a sealed and clean storage bag and placing them in a dry area. You can launder with other items, and then dry thoroughly.
- Canada's Chief Public Health Officer says if you've been exposed to COVID, and are
 asymptomatic, it is best to get tested around 4 to 8 days after your known exposure. If
 you get tested before or after that window, the likelihood your test result is incorrect
 increases.
- Transport Canada is now requiring doctor's notes from air passengers who say they

First Nation-specific Updates

- Today, Minister Miller announced a new \$305 million investment into the COVID-19 Indigenous Community Support Fund. Additional funds will flow directly to bands, and a new call for proposals will be set up for a secondary funding pot. (*Details below*).
- Canada announced a new \$40 million fund to support Indigenous businesses with their pandemic recovery.

FNIHB is encouraging people to have their vaccinations up to date, including the
upcoming flu vaccine, because of increased negative health outcomes from
contracting other diseases along with COVID-19.

NEW New Money for the COVID-19 Indigenous Community Support Fund News Release

Indigenous Community Support Fund (About, Who it Supports, How it Works)

Today, Minister Marc Miller announced the 'second round' of funding for the Indigenous Community Support Fund "to "ensure communities have the resources they need, "to weather the ongoing pandemic." The national AFN office tells us that:

- An additional \$112.5M will be made available directly to bands based on a similar formula to last time (slightly adjusted to address concerns about landless bands).
- An additional \$160M made available through calls for proposal or application bands, tribal councils, urban and off-reserve (details are still being fleshed out on this pot)

In terms of delivery we are being told that this new funding for communities is expected to move relatively quickly (between a month to six weeks). New funding for the application process will be delivered as applications are received and approved. However, applications do not yet appear available. We will continue to provide updates on this funding announcement in this bulletin as we receive them.

NEW \$40 Million for Indigenous Business Recovery

News Release: Government of Canada invests in Saskatchewan Indigenous businesses and communities

On Sunday, Economic Development Minister, Melanie Joly, announced an additional \$40 million to support Indigenous businesses through the pandemic. According to the Globe & Mail, the funding is separate from previous announcements like the \$300+ million given to Indigenous businesses for COVID-19 relief. There are 73 projects that will receive funding from this investment through federal economic development agencies. In Alberta, Western Economic Diversification (WED) is the agency responsible for distributing this funding, however, on

canada.ca WED identified only two Saskatchewan-specific projects as successful recipients of this new funding.

Federal Briefing on COVID-19 Response, August 11 & 12

Press Conference

Statement from the Chief Public Health Officer of Canada on August 12, 2020

Dr. Tam and Dr.Njoo led a briefing on COVID-19 yesterday. In lieu of an in-person briefing, Dr. Tam also issued a statement highlighting key data. **Key Highlights:**

- As of yesterday, there are 120,000 cases of COVID-19. 8,987 deaths have been reported. 88% of confirmed cases have recovered. 4.5 million people have been tested, with an average of 43,000 tests being conducted daily. 1% of cases are returning positive for an average of 443 cases a day.
- Responding to news that Russia has approved a vaccine, Dr. Tam says she is confident in Health Canada's processes for approving a safe vaccine.
 - Deputy Chief Public Health Officer Dr. Njoo says it is unusual how fast the vaccine was approved and that there is no clear information about its safety or effectiveness.
- A COVID vaccine will be effective if Canadians are willing to get vaccinated so "community immunity" is realized. Dispensing and distributing the vaccine will be a challenge.
- Dr. Tam says if you've been exposed to COVID, and are asymptomatic, it is best to get tested around 4 to 8 days after your known exposure. If you get tested before or after that window, the likelihood your test result is incorrect increases.
- Nationally, significantly fewer new cases are being reported daily compared to the more intense weeks of COVID-19, from late March to June. The number of new deaths reported daily has remained low following a steep decline from the peak in early May.
- Canadians under the age of 40 years have comprised over 50% of cases in the previous two weeks. Since early July, the incidence of COVID-19 has remained the highest among individuals aged 20 to 29 years in particular, but is now on the decline.

Alberta Update on COVID-19, August 12

Press Conference

Today, Dr. Hinshaw provided another update about the province's response to the ongoing COVID-19 pandemic. **Key Highlights:**

- Dr. Hinshaw is recommending that all Alberta teachers and school staff get tested before September, and regularly throughout the school year (though it is voluntary).
 - She says children should be tested only if they have symptoms or pre-existing conditions similar to COVID-19.
- Public health protocols are being developed if a staff member or student tests positive while in school. These are expected to be released soon.
- Dr. Hinshaw was asked why testing of teachers and staff will not be done at school? She says they are looking at "multiple options" for enhancing testing later on, but reiterated her recommendation for teachers to be tested *before* school starts.

- She also noted that NHL testing in Alberta is being done privately and, therefore, isn't burdening the public health testing done by AHS.
- Dr. Hinshaw says families should consider stopping visits with grandparents during the first month of school, or adapting how those visits happen by maintaining strict distancing and other safety measures.
- 1 in 7 Albertans have been tested for COVID-19 at least once. 316,000 tests have been done on asymptomatic people with 0.1 per cent returning positive.

Alberta Update on COVID-19, August 10

Press Conference

Dr. Hinshaw provided an update on Monday with regards to the province's response to the ongoing COVID-19 pandemic. **Key Highlights:**

- 257 additional cases were identified over the weekend, bringing the total number of active cases to 1,090. New cases were confirmed in all zones in Alberta. To date, 1,836 cases have an unknown exposure. 5 new deaths were reported over the weekend.
- There are 47 active cases and 897 recovered cases at continuing care facilities; 150 facility residents have died.
- Alberta is providing an additional \$48 million for people struggling with homelessness during the pandemic.
- Alberta has published a <u>re-entry tool kit</u> to prepare parents and students for back-toschool.
 - Dr. Hinshaw has been asked about reducing "social cohorts" when school reopens.
- The province has also released a <u>risk assessment tool</u> to help you know if you are at a high risk of having a severe outcome if you contract COVID-19, and how to mitigate it.
- The Misericordia Hospital remains closed to new patients because of a COVID-19 outbreak
- AHS is working closely with Good Samaritan Southgate Care Centre to deal with an
 outbreak in the facility. An exemption was granted to allow additional staff to support the
 facility and ensure residents are properly cared for.
- There are two cases linked to Bright Path Richmond child care centre in Calgary. Contact tracing is happening and testing is being offered.
- Dr. Hinshaw recommends storing clean reusable masks in a sealed and clean storage bag and placing them in a dry area. You can launder with other items, and then dry thoroughly.

Some Alberta First Nations adopt separate back-to-school plans from province

Alberta Announces Additional COVID-19 Homelessness Supports

News Release

Alberta is providing an additional \$48 million for people struggling with homelessness during the pandemic. **Key highlights:**

- Funding will go to shelters and community centres to continue operating safe, health spaces for those experiencing homelessness.
- This funding is in addition to \$25 million announced in March 2020.
- Funding ensures expanded shelter spaces in Edmonton, Calgary, Red Deer, Lethbridge and Grande Prairie, Lac La Biche, Lloydminster and Drayton Valley continue to operate.
